We do not use cash at camp, so the Camp requests that your camper be given a "Charge Limit" to be used during his/her stay. This limit may be adjusted by parents/guardians during the Camp session. The amount used by your camper during the session will then be charged to your VISA/MC/AMEX after the close of the session and an itemized statement of expenses will be sent to parents.

It is difficult making general recommendations for spending because of the varying camper ages and experiences handling money. However, listed below are examples of typical expenditures.

**Pro Shop** - Small items (grip tape, stationary, wrist bands, etc...) \$5-\$15, Camp Sweatshirt - \$20-\$35, T-Shirts - \$8-\$15, Racquet restringing - \$20-\$30.

**Snack Shop** - All items are \$.75-\$2.50 (drinks, candy, nutrition bars, etc...). The Snack Shop is available in the afternoon each day and each camper is limited to two snacks (either 2 sodas, 2 candies, or 1 soda & 1 candy) per day. The kitchen has food and drinks available all day long at no charge.

**Camp Photo** - Session photo is \$15.00 and is ordered by your camper at the time the session photo is taken.

**Camp Laundry** - \$12-\$20 - only done for campers staying two weeks or more

**Carmel Trip (2 week session)** - Lunch \$10-\$15 (Campers may request a bag lunch from Camp at no charge.) Individual purchases - \$5-? (Amount determined by individual camper age and desire to purchase gifts, etc...). The maximum we will give campers will be \$75 for the Sunday excursion.

Please state a dollar amount as to the "Maximum" for each camper. Totals should include desired spending money for Pro Shop, Snack Shop, Camp photo, laundry and Excursions (two week session). The most common amounts we see for a two week session are \$100-\$200 and for a one week session \$40-\$100.

**Cancellation Policy:**

Those made prior to May 1 will receive a refund less the \$300.00 nonrefundable deposit.

Cancellations made after May 1 will receive a refund, less the \$300.00 deposit, only if the space can be filled by the Camp. If the space cannot be filled by the Camp, no refund will be made.

*Summer camp is a wonderful experience for boys and girls and teaches them a great deal about themselves and the world around them. Part of the magic of camp is that the activities take place in the out of doors and campers are invited to explore new challenges. Obviously with these challenges comes risk. Our purpose in this disclosure is not to worry you, but to point out that there are risks connected with the fun, excitement and adventure of a camp experience.*

**Assumption of Risk.** You, as parent and/or guardian of your child(ren) are aware of the inherent risks of injury, death, and property damage involved in camp activities including but not limited to ropes course, swimming pool and hot tub, archery, volleyball, basketball, tennis, hiking, overnight campout including without limitation risks due to drowning, near drowning, falls, etc. You, as parent and/or guardian of your child(ren) are aware of the risks of injury, death, and property damage that may result from, among other causes, the act of active and passive negligence of Tennis Camp, Inc. (dba Carmel Valley Tennis Camp), all officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "related parties"), including without limitation the risk of negligent instruction or supervision. You, as parent and/or guardian have voluntarily allowed your child(ren) to engage in activities including but not limited to ropes course, swimming, tennis, hiking, etc., with knowledge of the risks of injury, death, property damage, and other risks, and assume any and all known and unknown risks of injury, death, and property damage that may result from camp activities including but not limited to ropes course, swimming pool and hot tub, archery, volleyball, basketball, tennis, hiking, overnight campout, etc.

**Release of Liability.** You, as parent and/or guardian of the child(ren) hereby release the related parties from all liability to you as parent or guardian, and or child(ren), principals, employees, agents, representatives, guardians, successors, assigns, heirs, and next of kin for all liability, claims, damage, or demands from personal injury, death, or property damage, arising from or related to this agreement or to camp activities including but not limited to ropes course, swimming pool and hot tub, archery, volleyball, basketball, tennis, hiking, overnight campout, etc., whether the injury, death or property damage occurs on or off the premises. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of any of the released parties. You, as the parent and/or guardian of the child(ren) bear sole responsibility for any loss.

**Hold Harmless.** You, as parent and/or guardian shall indemnify, defend, and hold harmless Tennis Camp, Inc. (dba Carmel Valley Tennis Camp), all its officers, directors, shareholders, employees, agents, representatives, successors, assigns, and heirs (collectively, "indemnatee"), against all liability, demands, claims, costs, losses, damages, recoveries, settlements, and expenses (including interest, penalties, attorney's fees, expert witness fees, costs, and expenses) incurred by indemnatee ("losses"), known or unknown, contingent or otherwise, directly or indirectly arising from or related to your child(ren)'s participation in Tennis Camp, Inc. (dba Carmel Valley Tennis Camp) activities.

**Choice of Law; Jurisdiction.** All questions with respect to the construction of this agreement and their rights and liabilities of the parties shall be determined in accordance with the applicable provisions of the laws of the state of California.

**Knowing and voluntary execution.** You, as parent and/or guardian of the child(ren) acknowledges that you have carefully read this agreement, understand its contents, understand that this agreement includes an assumption of the risk of the released parties negligence and a release of their liability. You, as parent and/or guardian of the child(ren) acknowledge that Tennis Camp, Inc. (dba Carmel Valley Tennis Camp) is materially relying on this waiver and is allowing your child(ren) to engage in camp activities including but not limited to ropes course, swimming pool and hot tub, archery, volleyball, basketball, tennis, hiking, overnight campout, etc.
